BAGGAGE GUIDELINES PER PERSON

Our baggage requirements are important for the safety and security of passengers and crew. Baggage must be portable; each piece easily and quickly moved by crew members as needed.

We ask for your cooperation regarding baggage transport. We will do our best to accommodate your baggage and ask for your assistance. We understand the special needs for the transport of construction equipment. Please follow these guidelines for size and weight.

SPECIAL NOTES

Medium size Stanley Box or one that measures up to 23"x23"x37" is acceptable with a maximum of 50 lbs. The largest Stanley or Husky Boxes are problematic. They must be under 50 lbs. and be able to be stored on their sides or up on end if necessary.

All non-baggage items travel at owner's risk.

No four-wheel carts or fixed wagons. **Two-wheel dollies** are acceptable to assist transporting luggage. Two 50 lb. luggage bags can be placed on the two-wheel dolly. Each remote luggage cannot be larger than 23"x23"x37" and weigh no more than 50lbs. Total weight on the dolly cannot exceed 100 lbs.

GENERAL BAGGAGE GUIDELINES

Baggage Guidelines per Person

Two pieces of baggage.

50 lbs. maximum each baggage.

Baggage must be within the dimensions of 23"x23"x37".

One carry-on bag to be stowed under the seat.

NOT PERMITTED ON VESSELS

Any gas powered tools, machines, engines, or generators

Building materials, plywood, tile, oil, lumber, and wood

Trash cans over 13 gallons

Lead acid batteries or large lithium ion batteries

Wheel barrows or ladders

Over weight tools or equipment

SPECIAL TRAVEL TIPS FOR SUB-CONTRACTORS & RELATED WORKFORCE

- No four-wheel carts or fixed wagons.
 - *Four wheel dollies or hand trucks that convert onto two wheels are permitted. Must be converted onto two wheels before going down the ramp and through the duration of the boat ride.*
- Hand tools are allowed. Tools must be enclosed in sturdy baggage or case that can withstand ordinary handling.
- Electric tools that are corded that fit within 23''x 23''x 37'' at 50 lbs. or less are allowed.
- Electric tools that are cordless and have a battery please call in for clarification.
 - *Rechargeable nickel cadmium batteries are acceptable.*
 - *Lead acid batteries and large lithium ion batteries are not permitted.*
- Any sharp tools must have a protective cover and must be enclosed in sturdy baggage or case that can withstand ordinary handling.
